The last day to register in any manner other than in-person with the local clerk is: Monday, July 22, 2024.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL168.497) at the Township Clerk's office, located at 64151 Territorial Rd. W, Hartford, MI 49057 at the following times:

- Saturday, August 3, 2024, 9:00 a.m. – 5:00 p.m.
- Election Day, August 6, 2024, 7a.m. – 8 p.m.
