PUBLIC HEARING AND MEETING NOTICE

TO: THE RESIDENTS AND PROPERTY OWNERS OF THE TOWNSHIP OF KEELER, VAN BUREN COUNTY, MICHIGAN, AND ANY OTHER INTERESTED PERSONS:

PLEASE TAKE NOTICE that the Keeler Township Zoning Board of Appeals will hold a public hearing and meeting on Tuesday, October 15, 2024, commencing at 7:00 p.m. at the Keeler Township Hall, 64151 Territorial Road West, Hartford, MI 49057, within the Township.

PLEASE TAKE FURTHER NOTICE that the item(s) to be considered at said meeting are as follows:

- The request of property owners Tracy and Justin Paruszkiewicz (“applicant”) regarding the property at 66406 Lakeshore Drive, Dowagiac, MI 49047 (Parcel No. 80-12-170-165-01) located in the “LR” Lakeshore Residential District Classification requesting a 6’ 10” variance from the required 10-foot side yard setback contained in Section 8.0 A of the Zoning Ordinance in order to permit the continued construction of deck on the southwest side of the existing house (Lake Shore Drive side) by continuing the nonconforming northwest side building line 3.2” from the adjoining parcel (Lot 11 Woodland Beach) and for an 5-foot variance from the required 30-foot front yard setback contained in Section 8.04 A. of the Zoning Ordinance in order to permit the deck to be constructed 25 feet from the right of way line of Lake Shore Drive parallel to the existing building line. Standards of review for consideration by the Zoning Board of Appeals are contained in Section 17.01 of the Township Zoning Ordinance.

- Such other and further matters as may properly come before the zoning board of appeals.

Anyone interested in reviewing the application for the above variance request or the Township Zoning Ordinance may examine a copy of the same at the Keeler Township Hall during regular business hours of regular business days hereafter until noon on the date of the hearing and may further examine the same at said public hearing/meeting. The Township Zoning Ordinance is also accessible via internet at www.keelertownship.org.

Written comments will be received from any interested persons concerning the foregoing by the Keeler Township Clerk at the Township Hall at any time during regular business hours up to the date of the hearing and may be further received by the Zoning Board of Appeals at the hearing.

All interested persons are invited to be present at the aforesaid time and place.

Keeler Township will provide necessary reasonable auxiliary aids and services, such as signers for the hearing impaired and audio tapes of printed material being considered at the hearing, to individuals with disabilities at the hearing upon four (4) days' notice to the Keeler Township Clerk.
